## TUBERCULOSIS ASSOCIATION OPENS 10TH CHRISTMAS SEAL CAMPAIGN

Three children lifting up their voices in a carol of the season is the pictorial theme of the 1940 Christmas Seal Sale of the Tuberculosis Association, with headquarters at Palama Settlement.



The cherubic faces expressing so vividly the spirit of youth and joy come from the brush of Felix Martini of Los Angeles.

This is the 10th annual Christmas Seal Campaign of the Association, the first having been held in 1931 by the Tuberculosis Committee of Palama Settlement.

Projects financed by the present campaign will include the production of a color movie on tuberculosis facilities in the islands. Extensive showing of this film to clubs, schools, and organizations in the territory is expected. This production is a joint

project of the Chamber of Commerce of Honolulu and the Tuberculosis Association. Other projects subsidized by the Christmas Seal Association are the sheltered workshop for discharged patients, case-finding programs in schools and industry, distribution of educational materials, such as posters and booklets, and assistance with the school health class program.

# AMATEUR BOXING MEET 7:30 P.M. - NOVEMBER PALAMA GYM <del>\*</del>

Coach Masuto Fujii's hard-fighting Tony Gora outfit won the 1940 Citywide-Palama 130# barefoot football league championship by whipping Ben Ahakuelo's Moiliili Blue Devils 9-7 after a thrilling uphill battle before 2,000 rabid fans Sunday, November 3, at the Honolulu Stadium.

Joe Goshima, sensational Gora halfback, gave the Ramblers sweet victory in the closing seconds of a bitter struggle with a 29-yard field goal which split the uprights and also Moiliili's heart.

Moiliili Blues enjoyed a seven-point lead gained early in the opening quarter until the last five minutes of the ball game when Goshima tallied from the fiveyard stripe after snapper-back Spike Nakayama had recovered a Moiliili fumble. Goshima failed to tie-up the tussle by conversion but came through in spectacular manner with only 30 seconds left to play.

Yoshio Kurihara scored for Moiliili from Tony Gora's 15-yard line after taking a 20-yard pass from Tokio Horita early in the first period. Wallace Nakano dropkicked the extra point, giving Moiliili a big lead which Tony Gora failed to wipe out in three great drives during the second and third periods.

Tony Gora was West Section champion and Moiliili Blues East titlists of the 16-team Citywide-Palama league.
