## ALEX SANDWICH SHOP WINS ACA CAGE TITLE

A large crowd of cage fans saw the fast Alex quintet out-play and out-smart the favored Tuxedo outfit to win in a walk.

Alex Sandwich Shop piled up an impressive 13-0 lead in the first quarter behind sensational shooting by Jimmy Lam and fine defensive play by Wai Cheong Chun and Bob Wong.
