LEADERS' CAMP-CONFERENCE HELD AT WAIALUA

Thirty-four club-leaders and staff members of the Palama Recreation Department attended the Joint Leaders' Camp-Conference held November 4-5 at Waialua. Settlement director Dr. Philip S. Platt headed the fine delegation of recreation and club workers which convened at Palama's beautiful seashore camp and accomplished much in conference and social activities.

Two joint discussions on topics selected by the program committee gave all present opportunity to express and contribute view-points. A scheduled lecture by Dr. Faith Gordon, noted visiting psychiatrist and sociologist, failed to materialized when an unfortunate mishap in transportation robbed the leaders off the pleasure.

Chairman Kent Nakamura opened the discussion panel Saturday night by presenting Tax Offices for two weeks. the subject "What Makes For Better Cooperation In The Recreation Department." After free expression of opinions from the floor, Nakamura closed the session with a summarization of what had transpired. The first conference went on record as agreeing that joint activities (picnics, projects, socials, etc.) make for cooperation between the boys' and girls' divisions.

Gordon Virgo, manager of the Waialua Agricultural Company and one of Palama's pioneer workers, led the group in singing immediately following the discussion. Mr. Virgo also gave the assembly a running word-picture of the Settlement's history and humble beginning.

Sarah Kim led the second discussion Sunday afternoon on "Essentials Of A Leader." Following lengthy debates, the conference adjourned standing pat on the findings that neat appearance, good personality, and training are a few essentials of a club-leader.
