# TAMANAHA WINS PAL HANDICAP MARATHON RUN

Norman Tamanaha, veteran Winged "P" road-running ace, added another title to his long list by winning Palama Settlement's 2nd annual handicap marathon run Sunday morning, December 25. Tamanaha negotiated the distance, a 6.9 mile run, in 35 minutes, 58 and five-tenths seconds, beating a fine field of 19 harriers to the finish.

Albert Chun, for many years a Pal mainstay, was second in 36 minutes flat, and William Badjadali, former Waialua kingpin, third in 37 minutes 20.1 seconds. Tamanaha, Chun, and Badajali ran from scratch, while the others were given handicaps of from one to six minutes.

Robello finished in fourth position just a step behind Badjadali, but his one-minute handicap gave him an elapsed time of 38 minutes, 22.5 seconds.

Medals were awarded to the first four winners by Louis Mendonca, coach of the Pal marathon team. The run was designed by Mendonca as a conditioner for the Diamond Head five-mile race slated Monday, January 2, 1939, and as a try-out for the berths on the Palama team for the Around-Oahu Marathon Relay classic scheduled Sunday, January 15. The Pals are given better than an even chance to cop individual and team championships in both races.

### PAL BOXERS MEET HAW'N PINERS DECEMBER 28

Westside fight fans will be given their second treat of fistic action within a month, this Wednesday evening, December 28, when the Winged "P" mitt-slingers tangle with the Hawaiian Pine sluggers in a dual amateur boxing smoker at the Palama gym. The opening bout is scheduled for 8:00 p.m.

The Palama Community 120# basketball league neared the close of its regular schedule as the three sections completed their fifth week of play at the Westside gym.

Richard Kato's Nuuanu Y cagers opened Section "A" tussles Monday, December 19, by taking Pirates "A" 25-17. Yano shone for Nuuanu Y by scoring 10 points. Eki Cyclery clinched a spot in the champion-ship round-robin that will follow the regular tournaments by overwhelming Desha Lane 50-26, with G. Eki, T. Mizukami, and Miyamoto scoring heavily. Miyamoto tallied 15 points and Eki and Mizukami 12 each. Makiki dumped Anchor Cafe 20-15 in the last game of the evening behind Sakuma's 10 points.

Elmo Tomita's Club Billiard Parlor took a 2-0 default from Maui Inn in the first game of a scheduled triple-bill Tuesday, December 20. Pirates "B" nipped a traditional rival 27-25 in downing McInerny. W. Young sparkled for the Pirates by regis tering 10 points. McInerny's Sagawa, however, copped high-scoring laurels with 13 digits. Hui Eleu walloped Kyodo Kai 43-30 in the final game of the night with Lum tallying 18 points, and Wun 12.

McCully whipped Castle A.C. 26-13 in the opening skirmish Thursday, December 22 behind Sugimoto's 16 points. The victory gave McCully a place in the championship round-robin. Sumida Express also qualifield for the play-offs by taking Rengo Kai 21-17. Kato twinkled for Sumida by connecting for 10 points. Alexander's Sandwich Shop lowered the curtain on the week's 120# basketball activities by chopping the Riders 20-16.

# PIRATES CROWNED 135# BASKETBALL, CHAMPIONS

Tommy Wong's well-balanced Pirate outfit crowned themselves 1938 Palama Community 135# cage champions by outscoring McInerny, defending-titlists, 52-40, in the finals of the 135# play-offs before a large crowd, Friday, December 23, in the Palama gym.

Both teams earned the right to meet for the title by eliminating rival squads Wednesday night. The Pirates turned back Castle A.C. 31-27, while McInerny took Riverside by a 29-22 count.

Lawrence Chun led the Pirates to their scintillating victory over McInerny by tossing in 19 points from all angles of the floor. He was accorded brilliant support by Raymond Chun with 11 points, Loui with 10, and V. Wong with nine markers. The Chun boys completely dominated play from their guard positions, ringing the basket from long range and slipping in for layup shots with spectacular consistency besides flashing bang-up performances on defense.

The Monarchs were outclassed from the opening whistle as the Pirates outpassed, outshot, and outmanuevered them in sensational manner. The Pirates' floor-work and ball-handling, especially that of Raymond Chun, were dazzling at times.

Mahukona and Silva, with 11 points each, did yoemen work for the defending champions, but could not cope with the great all-round strength of the Pirates.

The newly-crowned 135# champions ruled the 120# roost for several years, enjoying undefeated campaigns in 1936 and '37, and performed this season in the 135# league for want of competition.

### PALS BOW TO CITYWIDE IN JR. ASUH CAGE MIX

An inspired Citywide quintet upset Fil Marvin's Winged "P" cagers 50-41 in a crucial Junior ASUH tilt last Thursday evening at the University of Hawaii gym. The setback was Palama's first in four starts. A victory would have placed the Pals in the championship play-offs.
