DAVID ROMAN WINS OUTSTANDING NOVICE AWARD

David Roman, rookie Palama lightweight whose flashing fists carried him into the semi-finals of the Oahu A.A.U. Boxing Tournament against experienced opponents, has been ajudged the outstanding novice boxer of the season by a select group of sport-writers. The announcement was made Saturday evening, March 16, during intermission of the territorial semi-finals at the Civic Auditorium.

Roman's selection received popular acclaim by fans who have followed the careers of every boxer in the tournament. In winning the award, Roman nosed out Paul Inamine and William Gonsalves, both of CYO.

The Palama battler won three of his four bouts by knockouts and gave Paul Matsumoto, territorial lightweight finalist, a great fight. Roman handled himself like a veteran in all his bouts, and flashed championship potentialities in his first year of competition.

HENRY LEE WINS A.A.U. NOVICE MAT CROWN

Henry Lee, Palama's flyweight surprise in the A.A.U. Boxing Tournament, gave Westsiders another pleasant jolt by copping the flyweight championship of the Novice Wrestling Tournament held last Thursday, March 14, at the Nuuanu YMCA. The Korean lad upset R. Mitsunaga of the University of Hawaii in the finals to gain the championship.

Lee's performance rounded out a brilliant season in A.A.U. athletics after several mediocre years. He gained Class II in boxing, against the best flyweights in the island, decisioning Paul Inamine in one of the greatest upsets of the tournament. Lee seems to have "arrive" and great things are expected of him next year.

PAUL GARCIA CRACKS UNLIMITED B.C.A. RECORD

Paul Garcia provided the big thrill in last week's B.C.A. pentathlon practice when he shot 26 baskets Thursday, March 14, in the Westside gym. Garcia's mark unofficially cracked the Unlimited record of 25, made by Archie Kapahua in 1937 and tied by Charley McKee last year.

Garcia's performance bordered on the sensational as he had never caged more than 20 goals in his five years as a B.C. A. competitor. By virtue of his spectacular improvement in his weakest event, Garcia rules a heavy favorite to cop the Unlimited title from Charley McKee and Buster Lee, his closest rivals.
