COMMUNITY VOLLEYBALL LEAGUE OPENS TONIGHT

Palama Settlement's 1940 community volleyball league will shed its wraps with a fast twin-bill this evening at the West-side gym. Hui Hawaiian is scheduled to tackle Makani A.C. in the circuit-opener at 7:00 p.m., with Just Step Inn slated to show against Palama in the second tussle at 7:30 o'clock.

Fern A.C. will stack up against American Sanitary Laundry in the first game of a double-attraction Thursday, May 16, at 7:00 o'clock. Gulick Store meets Ala Moana in the second tilt at 7:30 p.m.

The league will operate every Tuesday and Thursday evening, with twin-bills listed on all playing nights. Eight outfits will battle for the title vacated by Kakaako Sons, champion in 1938 and 1939. Comprising the league-roster are Hui Hawaiian, Makani A.C., Just Step Inn, Ala Moana, Palama, Fern A.C., Gulick Store, and American Sanitary Laundry.

Barred from participation in the loop are players who possess Senior A.A.U., Senior A.S.U.H., Commercial, and Citywide Open League experience. Teams must report on scheduled time ready to play. The penalty for tardiness is forfeit, with two defaults eliminating a team.

PHANTOM SOFTBALLERS TAKE CHARLIE CHAN 9-5

Phantom A.C. gained the finals of the Palama softball championships Sunday, May 12, by whipping Manager Ernest Kauhane's Charlie Chans 9-5 at Castle field, Palama. The Phantoms will meet Sylvester Abili's Castle Club for the 1940 title at 10:00 a.m. Sunday, May 19.

A sensational rally in the lower half of the eighth inning which netted five runs enabled Phantom A.C. to emerge on the long end of the hard-fought battle. The Phantoms led 4-3 after seven chapters and their five-run splurge proved too much for Charlie Chan's last inning attempt to gain a victory. Phantom A.C. tallied two runs in the first inning, two in the fifth, and five in the fatal eighth, while Charlie Chan registered two runs in the fourth stanza, one in the sixth, and two in the ninth.

Sin went great guns for Phantom A.C. in the box and was accorded brilliant support by his team-mates. Collins and Rio worked the pitching assignment for Charlie Chan.

PALS FINISH THIRD IN 16TH RAINBOW RELAYS

Palama Settlement's small but versatile squad of senior spikesters, coached by Charley Ornellas and Reed Maxson, finished a close third behind University of Hawaii and Waimanalo A.C. in the 16th annual Rainbow Relays sponsored by the ASUH staged last Saturday, May 11, on the Alexander Field cinder-paths.

Tommy Kaulukukui's Roaring Rainbows copped first place with 73 points, Waimanalo A.C., Olz, and Palama 56. Maui's sixman team tallied 22 digits for fourth place, followed by Citywide A.A. with 19, OPAA with 8, and Unattached with ½ points.

Winged "P" stars accounted for two of the three records broken at the carnival, when dusky Bill Nadal erased team-mate Bob Freitas' high-jump mark of 6' 15/16" with a sensational 6' 1 3/8" effort, and Herb Bodner tied with Pete Beamer of Waimanalo at 12' 4 5/16" in the pole-vault. Other blue-ribbon winners for Palama were Howard Fernandez in the broad-jump, and John Hodges in the 100-yard Novice Dash. The Settlement two-mile relay squad of Chun, Tamanaha, Choo, and Ornellas, whipped a fine field in 8 minutes, 36.6 seconds for its lone relay-victory.

MARKET MUSIC WINS CHINESE CAGEBALL TITLE

Coach Vernon Wong's star-studded Market Music outfit won the Chinese Civic Association's 1940 Novice Basketball League title by nipping a stubborn Atoms quintet 35-34 Sunday, May 12, before a capacity crowd at the Westside gym. Larry Chun's Alex Sandwich Shop gained the runner-, up trophy with a close 22-20 victory over an exhausted Narcicuss crew which had played two hard games earlier in the day.

The championship tussle was action and thrill-crammed throughout, as the underdog Atoms carried the battle to their more experienced opponents. Mun Kin Wong sparked Market Music's victory with sensational shooting, which was matched by Atoms' Harry Ching. Spectacular rallies carried the Atoms to within an ace of victory twice, but in each instance, Market Music came through like champions. With the count standing at 33-26 with four minutes of play remaining, the Atoms stormed Market Music's basket, and with Ching dumping in three successive goals, swept into a 34-33 lead with seconds left in the game. However, Mun Kin Wong produced with a beautiful sideshot to regain the advantage and sew up the ball game. Atoms missed three easy cracks at the bucket in the dying seconds.

Also starring for Market Music were Richard Loui and Given Goo. Dickie Wong was a bulwark on the Atoms' defense.

League-manager Tommy Wong has called a meeting of all officials and team-managers to decide winners of the beautiful awards at stake for the most valuable player, and for the best sportsmanship and best dressed teams.

The Winged "P" team is built around stars from the territorial deaf and dumb school, who have served as the backbone of the Palama squad for the past several years. Heading the list is Susumu Kobayashi, all-round gymnastic champion last year, who is reported to be in fine shape.

Exercises on the horizontal bar, parallel bars, flying rings, side-horse, and in tumbling are compulsory contests in the gymnastic program which will show top-notchers from Maui County, University of Hawaii, Salvation Army, Nuuanu YMCA, and Central YMCA, besides the Pal entries.

A.A.U. TRACK & FIELD CHAMPIONSHIPS SATURDAY

The 1940 A.A.U. Track and Field Championships is scheduled for this Saturday, May 18, on the Punahou cinder-paths, with pit events slated to go on at 1:30 p.m., and running events at 2:00 o'clock. Tommy Kaulukukui's University of Hawaii spikesters, Rainbow Relays champions, will head a strong contingent of six clubs into the competition for attractive team and individual prizes. Waimanalo A.C., Palama Settlement, Citywide A.A., Maui County, and OPAA are other competing outfits.

Feature of the meet will be the 10-mile marathon race. Palama's Norman Tamanaha, Albert Chun, Burton Hooper, and William Bajadallis are doped to give the favored Walter Gouveia a battle for first place.

Games-chairman Ralph Olsen has announced that the A.A.U. will send the athlete whose performance Saturday compares most favorably with Mainland marks to the National Junior Championship at Fresno City in June. Winged "P" candidates for the signal honor are Bill Nadal, who cracked the Rainbow Relays high-jump mark with a 6' 1 3/8" effort, Herb Bodner, co-holder of the Relays pole-vault record at 12' 4 5/16", and Charley Ornellas, who has smashed two minutes in the 880-yard run.

Trials for all events with more than six entrants will be held Thursday, May 16, beginning at 4:00 p.m. on the Punahou cinder-ways.
