


















#### PRESIDENT'S MESSAGE



Whether you are a Palama Settlement volunteer, employee, trustee, or program participant...each of you makes an important contribution to the success of this very special place. *Mahalo nui loa* for your time, energy, expertise and compassion. Five highlights come to my mind when I think back on what the Board of Trustees accomplished this past fiscal year:

- 1. Planning for a year-long Centennial celebration which kicks off on June 1 with an Old Timers Centennial Luau and will culminate one year from now. Paula Rath, chair of this committee, secured tremendous television, radio and newspaper coverage about Palama which have reacquainted the entire community with Palama Settlement, its past and its purpose. This will go a long way towards helping future fund raising efforts.
- 2. Voting to sell the land which Palama Settlement owns underneath the Palama Manor apartments. While the deal is not finalized, the Trustee's decision to pursue a sale was based on the desire to secure funds for operations and capital improvements. Special kudos (pun intended) to Ben Kudo, Palama trustee and partner in the law firm of Dwyer, Imanaka, Schraff, Kudo, Meyer & Fujimoto, who, along with his associate Kris Nakagawa, is handling the legal aspects of this sale pro bono.
- 3. Creating a Program Administrator/Fund Development position responsible for raising funds through a variety of ways including normal solicitations, grant requests and the creation of a planned giving program.
- Establishing a Girl's Residential Group Home Program and the Palama Family Service Center, which
  provide social services to Mayor Wright Housing and Kaahumanu Homes.
- 5. Improving the buildings and grounds of Palama Settlement including the Tenant Building, the court yard garden and the Leland Blackfield Activity Center. We owe special thanks to the Kalihi Businessmen's Association and the Honolulu Neighborhood Housing Services, Inc., who painted the hallways of the Tenants Building, the Garden Club of Honlulu who landscaped the court yard garden and Cecilia Blackfield and her daughters, Karen and Pamela, for major equipment purchases in the Activity Room.

Aloha United Way is the financial backbone of our operation providing 42% of our operating funds. We were fortunate once again to receive a much needed allocation from AUW. The remainder of our funds came from contracts with The Family Court, Office of Youth Services and Department of Human Services, rental and program fees.

Bob Rath, trustee emeritus, continued his supreme efforts in fund raising. As a result of his efforts, there are several other very generous individuals and entities that provide direct financial support including Henry Clark to establish the Frank L. Putman, MDScholarship Endowment Fund; the Strong Foundation, the Samuel & Mary Cooke Foundation, the Ing Trust, the Wilcox Foundation, the Mary D. & Walter F. Frear Eleemosynary Foundation, Karen Perkins, past president of Palama Settlement, Bank of Hawaii, First Hawaiian Bank, Campbell Estate/The James & Abigail Campbell Foundation, United Airlines Charities, Duty Free Shops of Hawaii and the Pettus Foundation.



Nineteen ninety-six saw the development of two programs: The Palama Family Service Centers and the start of the Girls Residential Group Home Program.

The Palama Family Service Centers, located at both Mayor Wright and Kaahumanu Homes, is funded by the Self-Sufficiency & Self-Support Division, Department of Human Services under the jurisdiction of the Title IV B Regional Planning Committee. We are delighted with the opportunity to offer services to the housing complexes, because of our long history of providing services to these communities.

The contract with the Department of Human Services gives us an opportunity to expand and achieve one of the major goals of our agency - to be of service to this community.

The Girls Residential Group Home Program was re-initiated, because of our committment to be of service to a wide spectrum of adolescent needs. Although we realized that this would be a very difficult program to administer, Palama had the resources and facility and wanted to make a meaningful contribution to a growing need in the community. We hope that as we gain more experience this specialized area and become successful in the operation, we will be able to expand the residential group home program.

Although there was a slight decline in our overall funding, we were very fortunate that any decrease was very minimal. In fact, we were able to expand and increase our services during this downturn in economic conditions. The contracts with the Department of Human Services, Office of Youth Services and the Judiciary have provided growth opportunities for Palama. In addition, gifts and donations from individuals, corporations, trust and foundations and the Aloha United Way have contributed immensely in support of our programs.

Although money is important in the operations of an agency, the success of the agency is really dependent upon the staff. Palama is fortunate in having a loyal, faithful and dedicated staff. Many of our members have been at Palama for a long period of time and have given unselfishly in fulfilling their roles and much more in making sure that the program succeeds. The Board and administration sincerely appreciate their efforts.

The Board of Trustees has also been very busy and helpful in lending their expertise to the operation of the agency. As we approach the Settlement's centennial year, the Board Centennial Committee, composed of board members, staff and past participants, have been busy meeting and outlining the plans for the Centennial Celebration Year. The Board has also been meeting on crucial areas such as: revising the Constitution and By-Laws, Personnel Policies, finances, land and facility concerns.

The growth of programs and services and the increase in the Board's work this past week have created additional work - particularly for the administrative staff. We are grateful for the continued services of Amy Fujii and volunteer, Ingrid Alvarico, in providing the much needed administrative support help.

In closing, I want to express the Settlement's thanks to the many volunteers who have given thousands of hours to precious time and energy to our programs. These include coaches, parents, tutors, instructors, general overall helpers that, each in their own way, have made Palama Settlement a better place today.




