### BOYS' SUMMER SCHEDULE TO BEGIN JUNE 17

The Recreation Department's annual Summer Program for boys will begin Monday, June 17, and continue until Saturday, August 17, it has been announced by leaders of the Boys' Division. Registration for all classes and activities on the program is scheduled June 17-21 at the Boys' Clubhouse with either Harry Lee or Raymond Choo.

Many and varied craft and physical education classes will be offered under capable leadership. Again, as in the past two years, shopwork will be directed by an instructor from the Department of Public Instruction. Reed-weaving, which proved so popular last summer, will be a feature of the 1940 craft-class projects.

Furniture-making, Carpentry, Leather-craft, Drawing, Pyrography, String Belt Making, and Linoleum Block Printing will also be taught at scheduled periods.

Beginners' and Advanced Gym & Tumbling, Physical Culture, Weight-Lifting, Wrestling, Swimming, Tennis, Water Pageant Practice, and Free Gym Play classes are listed under the Physical Education program.

Other features of the Summer Program will be a bi-weekly movie and excursion, a Water Pageant on July 17, and a big Aerial Circus July 26-27. The 1940 Summer Schedule will close with a mammoth three-day camp at Palama Settlement's beautiful Fresh-Air Campsite, August 19 to 24, at Waialua, Oahu.

Fern A.C., another Kalihi team, held second spot with three wins in as many starts, while American Sanitary Laundry also remained unbeaten, with two victories.

The league offered six sizzling tussles on Monday and Tuesday of last week before large crowds. Fern A.C. opened the week's activities with a scintillating 15-4, 15-7 verdict over Hui Hawaiian in the first game of a triple-bill Monday, May 27. Diamond, Swan, and Fernandez were offensive stars for Fern A.C.

Gulick Store pounded out a hard-fought three-set victory over Just Step Inn behind fine slamming by Andy Keliikoa, Cleghorn Boyd, and R. Gohier in the second game. Scores were 10-15, 15-12, and 15-6. Ala Moana subdued Makani A.C. in another extended match by counts of 15-12, 9-15, and 15-10 in the final battle of the evening.

American Sanitary Laundry cleaned a weakened Palama squad 15-12, 4-15, and 15-12 in the curtain-raiser of Tuesday's triple-attraction.
