FINALS FOR BCA COMPETITIONS LISTED TONIGHT

Settlement finals for the annual Boys' Clubs of America Indoor Track and Swimming Competitions will be held at 7:00 o'clock tonight in the Westside gym and tank respectively.

The Settlement's young athletes are all primed to carry the Maroon banner to the top in both events, with months of hard training behind them in their assaults upon long-standing Palama records. The young Westsiders have been nursed into the pink of condition by Reed Maxson and Nelson Kawakami and are in fine mettle for the Settlement championships.

Events in the Indoor Track pentathlon are a standing broad jump, standing hop, step, and jump, running high jump, 1-minute basketball shoot, and pull-ups. Competition is limited to boys who have not reached their 18th birthday, and is divided into five classes; 80# 95#, 110#, 125#, and Unlimited.

The Swimming competition will embrace contests in a 20-yard Breaststroke, 20-yard Backstroke, 20-yard Obstacle, 40-yard Freestyle, and a 60-yard Freestyle race. Participation is open to all boys under 21 years of age, with competition grouped under four divisions; 12-13 years, 14-15 years, 16-17 years, and 18-20 years.

PALS BOW TO HAWAIIANS IN NET CHAMPIONSHIPS

Palama Settlement's tennis team bowed 4-1 to the Hawaiians in the Class "B" Net Championships held Sunday, April 14, at the Kapiolani Courts. The Pals were outclassed by the hard-stroking Hawaiians, and were able to salvage only one match from the rout, when J. Hewlett whipped H. Rutherford 7-9, 6-1, and 6-3 in the 1st singles.

Y. Nishida succumbed to Kauwila Akau 3-6, 3-6 in the 2nd singles; Y. Inouye and S. Kahanu lost to J. Puualoa and A. P. Medeiros 1-6, 3-6 in the 1st doubles; Tamura Brothers were beaten by S. Morse and J. Ahue in the 2nd doubles 4-6, 2-6; and T. Young and F. Chang fell before J. Guerrero and N. Aluli 5-7, 0-6 in the 3rd doubles.

Palama earned the right to meet the Hawaiians for the Class "B" championship by winning the Section One title with a record of 33 victories and 13 losses. The team was coached by Yoshiharu Nishida and Yoshita Inouye, veteran Palama netsters.

SETTLEMENT REIMBURSED FOR ATHLETICS

Checks for \$176.83 and \$154.26 were received last week by Palama Settlement from the ASUH Basketball and the A.A.U. Boxing Committees respectively. The remittances represented Palama's shares of the season's profits in the two sports.

The Settlement's share in the basketball proceeds exceeded any previous remittance ever received from the sport in one season by a Palama team. Much of the credit for Palama's entry in the ASUH Senior League this year is due to Reed Maxson, whose ambition and determination to have the Settlement represented would not be daunted, despite loss of several valuable players to other teams. With inexperienced and youthful material, Maxson whipped his charges into a surprisingly strong outfit which gave every team in its section a tough battle.

Refund from the A.A.U. Boxing Committee was based on the number of fights Palama landed in the tournament. Fourteen Winged "P" battlers participated in 35 bouts during the season, winning 19 of them. The heavy pay-off came in the championship bracket fights, in which Palama qualified five boys, four of whom came through with six bouts.

Two Palama fighters, Henry Lee, fly-weight, and David Roman, lightweight, reached Class II standing. Roman was acclaimed the outstanding novice fighter of the year, being defeated only by national champion Paul Matsumoto.

Carabian Braves scored a brilliant 3-2 upset over Charlie Chan to highlight the third week of action in Palama Settlement's Softball League Sunday, April 14, at Castle field. The defeat toppled Charlie Chan from the unbeaten ranks, leaving Waiaka, Honolulu Chop Sui, and Phantom A.C. at the crest of the 24-team field.

The hard-hitting Chans were halted by the puzzling delivery of Rodrigues, who scored repeatedly with his "cripple" ball. The Chans were blanked after scoring two runs in the first inning. Carabian Braves tallied one run in the 3rd inning and two more in the 5th to clinch the victory.

Phantom A.C. continued to play scintillating ball to shut out Desha Lane 3-0 behind fine chucking by Santiago. Castle "B" marred the day's schedule by defaulting 9-0 to Royal Malts.

Pal Babes chalked up a sterling 5-4 victory over Kaiulani for their second win in three starts. Bob Kau went great guns for the Pals on the mound and was given air-tight support. Palama A.C. remained in the running by pounding out an 8-2 triumph over St. Theresa.

Honolulu Chop Sui displayed championship form in crushing the Westsidiers 16-4 by virtue of a vicious batting attack. Ueno Shoten matched Honolulu Chop Sui's antics by burying the Akepos under a 15-4 avalanche. Waiaka walloped Lakimela 11-1 in another high-scoring victory for its third of the season. Castle "A" stopped the Vagabonds 9-4 to complete the 12-game schedule.
