### PRESIDENT'S ANNUAL REPORT

During the past year, the Board of Trustees held eleven meetings: nine regular monthly meetings and two special meetings. Attendance averaged thirteen trustees per meeting, and there was no problem about a quorum (five members) at any meeting. My thanks to the Board for the fine attendance record. Most of the meetings were held at the Pacific Club, through the courtesy of W. Russell Starr. My thanks to the Board members also, for their committee chores.

Through resignation at various times during the year we lost from the Board, with great regret, the following: Mrs. Ines Cayaban, Yoshiaki Nakamoto, Daniel E. Dorman, Keichi Osaki, Thomas Kaulukukui, and R. Allen Watkins. New members elected during the year were: Mrs. Ben H. Bond, Jr., Samuel E. F. Chu, and Judge Gerald R. Corbett.

On June 30, 1959, Director Walter H. Ehlers left to work for a doctorate at Brandeis University in Waltham, Massachusetts. On July 1, 1959, our new Executive Director, Arne E. Larson, arrived, with his wife "Nikki" and their eight-year old daughter. "Connie."

I am pleased to report that I have received enthusiastic commendation of Mr. Larson's work and his personal attributes from many sources, including the staff, and dental clinic personnel, the community at large, and officials of the Honolulu Community Chest and the Honolulu Council of Social Agencies. The amazingly successful Carnival-Bazaar held at the Settlement on November 6-7, 1959 was, in my opinion, an excellent proving grounds for the new director, and a copy of my letter to him is presented herewith as Appendix 1.

Much work has been done by Board members on the problems raised by the construction of the Vineyard Thoroughfare and the building of the new gymnasium. Work continues on the problem of obtaining the proper variance for the makai property. Special thanks go to Jack Clarke, Jr., Kenny Young, among others for their efforts on behalf of Palama.

The new gymnasium was officially opened with a dedicatory program on the evening of January 6, 1960. Despite inclement weather, over a thousand people attended. A copy of the program appears as Appendix 2 of this report.

For some years now it has been earnestly hoped that a thorough-going study might be made of Palama Settlement's program, to determine how it should be developed in order to best meet the needs of the community. A joint Commission of the Honolulu Council of Social Agencies and the Board of Trustees of Palama Settlement has been appointed to direct and evaluate such a study. Members representing the Palama Board are: Mrs. Nancy Hartwell, Judge Gerald Corbett, Lee Ward, Bobby Rath, Arne Larson and myself. Representing the Honolulu Council of Social Agencies are: Hung Wai Ching, Will B. Johnstone, Jr., Dr. Andrew Lind, Mrs. Ethel T. Mori, John C. Pixley and Yoshiaki Eto. Mr. Hung Wai Ching will be chairman of the Commission.

The actual data-gathering work will be done by staff members of the two organizations, with the assistance of volunteer helpers. It is understood that the Board of Trustees of Palama Settlement have the final authority to accept, modify, or reject any recommendations made by the joint Commission, following the completion of the study.

### EXECUTIVE DIRECTOR'S REPORT

### A Great Record

Palama has a great record of over half a century of pioneering and solid achievements. Founder James Rath, the first director, and the early Trustees established high settlement house standards for later directors and trustees to follow.

### Proud to be Participating

Half a year is a short time when measured in terms of Palama's long history but long enough to give the new director a truly grateful pride to be able to participate in the work of this settlement house.

### Working Together

Palama enjoys cordial working relationships with the Council of Social Agencies, the Community Chest, the Honolulu Housing Authority, the Kalihi-Palama Community Council, the Department of Public Instruction, the Parks and Playground Department and other agencies working with and for the people of this community.

The Friends of Palama, the Palama Neighborhood Association, the Pre-School PTA, and the Strong-Carter Dental Clinic are pillars of strength to the Palama program throughout the year, and year after year.

Friends of Palama sponsor tremendous Benefit Carnival-Bazaar.

Castle Foundation gives \$3000 toward bleacher fund for new Gym.

Oahu Railway and Land Co. contributes \$1,000 for Building fund.

Palama deficit chopped from \$12,000 in August to 800 in December.

### Increasing Needs

Population growth increases the need for the Settlement's services. More babies; people live longer; new residents move into the area—result: more need for programs for people of all age levels.

### Self-Survey

The Self-survey being undertaken jointly by the Council of Social Agencies and Palama Settlement is expected to evaluate Palama's present program and to make recommendations as to future policies and programs.

### In the Year Ahead

Palama should develop ways and means to:

- Expand and diversify activities so as to serve all age levels in the neighborhood.
- 2. Enlist the help of more volunteer leaders.
- 3. Reverse the annual decline in membership following the peak figure of 1953.
- 4. Strengthen staff morale, quality, continuity through improvement of salary scales whenever possible, and through cooperative working for Palama as members of one, undivided team.
- 5. Build up among the people of the Palama community a strong civic consciousness and fuller appreciation of the duty of all individuals and groups to live up to the ideals and principles of a great democracy, and in the best traditions of Hawaii Nei.


