

#### Palama Settlement Open House

State and County dignitaries, local agencies, schools and community residents were invited to attend an Open House for Palama Settlement on Friday, April 27, 1990 from 1:00 to 4:00 p.m. The major attraction for this Open House was the dedication of Palama's newly founded Computer Center which was funded through the generous contributions of The Atherton Family Foundation, Oceanic Cablevision Foundation, Samuel N. and Mary Castle Foundation, Cooke Foundation, Ltd., McInerny Foundation, The Junior League of Honolulu, Inc. and Alexander & Baldwin, Inc. Representatives from these foundations were recognized in a dedication ceremony which began at 1:30 p.m. with the blessing of the Computer Center, given by the Reverend David Twigg of Kaumakapili Church. A representative from the Governor's office. Deputy Director Tom Yamashiro of Budget and Finance, spoke to the guests on the importance of education to our community's youth. He also delivered a personal message from Governor Waihee commending Palama Settlement for it's service to the youth and families from the Kalihi-Palama Community. Palama Settlement's volunteers and special guests were recognized in a short ceremony at 3:30 p.m.

Throughout the Open House, Palama's programs and facilities were open to the public for view, and Palama's staff was available to answer any and all questions. Strong Carter Dental Clinic, Honolulu Neighborhood Housing Services, Na Loio No Na Kanaka (The Lawyers for the People), and Kaiser Health Plan Foundation also presented agency displays and answered questions for the guests in attendance. A light buffet and refreshments were provided.

#### **Note From the Executive Director**

Palama Settlement has been a bevy of activity over the past three months. A Community Easter Event was held on April 12, 1990 with over 400 community residents attending, and an Agency Open House followed two weeks later. Palama staff worked very hard to make both events a tremendous success.

Our Computer Center is in full swing now with youth from our Pakolea and In-Community Treatment Programs making great progress in computer competency using a wide variety of educational software.

We are especially grateful to Alexander & Baldwin for their generous donation of \$5,000 for the purchase of a Macintosh Computer and Laser Printer for the Computer Center.

In Recreation, swim classes for three local elementary schools were conducted and youth and adult volleyball leagues are in full swing.

Planning and Registration for our Summer Educational Program and Pakolea Football season are under way and we look forward to the next three months with a great deal of excitement and anticipation.

#### Easter Community Event

On April 12, 1990 over 400 people from the community enjoyed an Easter celebration on Palama Settlement grounds. The fun began with the arrival of Mr. Bunny and Cheryl the Clown. Youngsters from 3 to 12 years old eagerly lined up for the Easter egg hunt, which was held on Palama's field. Nine children found "special eggs" and received Easter baskets, overflowing with candy, as prizes.

The Hyatt Regency Hotel generously donated staff and food for the occasion. They set up barbeques and cooked and served hot dogs, hamburgers and soda to

One aspect of this program is the Cheerleader division, which consists of 36 Pee Wee, Junior Pee Wee, and Midget girls who range in age from 8 to 14 years old. These young girls attend all Football games and display a tremendous energy, excitement and enthusiasm for the games. They are a major contribution to our Pakolea Program. Their dedication to Palama Settlement and hard work in learning the routines has instilled a sense of belonging, of pride, and of accomplishment in these young girls. For the last three years, the Junior Pee Wee squad demonstrated these qualities by winning the first place award in the Pop Warner Cheerleaders Tournament at the end of each season.

The Cheerleaders' uniforms are an important element in helping the girls to maintain their sense of pride and self-esteem. The quality of their participation at the games and in competitions is increased with the knowledge that as a team, they "look good", as well as perform to the best of their ability. This year, the Pakolea Cheerleaders are in desperate need of new Cheerleader uniforms. We need to raise \$6,000 for new uniforms for the girls before August 1, 1990. 

Students Deanna Dunstone and Pam Masaki served their Spring practicum at Palama Settlement as assistants to the In-Community Treatment program staff. They were involved in supervision of the program youth, program planning, and individual tutoring. The students also had the opportunity to read case files, sit in on Court hearings and participate in group counseling sessions. We thank them for their service and sincerely hope that they received as much as they gave to our program.
