PHANTOMS WIN SECTION "C" SOFTBALL TITLE

A powerhouse Phantom A.C. outfit settled all doubts as to its supremacy in Section "C" of Palama Settlement's Softball league by blasting Ueno Shoten and Royal Malts from the championship picture in spectacular fashion Sunday, May 5, at Castle field, Palama. The Phantoms white-washed Ueno Shoten 8-0 in the first tussle and came back to duplicate the feat against Royal Malts and earn the right to represent Section "C" in the elimination^{play-off} between sectional champions for the league title.

The three teams were tied for the Section "C" crown after play in the regular schedule, with one loss each in five starts. Phantom A.C. is slated to meet Charlie Chan, Section "A" winner, at 9:00 a.m. Sunday, May 12, at Castle field in the first skirmish of the elimination schedule. Castle A.C., Section "B" champion, drew a bye and will meet the winner of the Charlie Chan-Phantom A.C. game for the league title.

Ueno Shoten took the full shock of the Phantoms' vicious hitting mood in the first inning, when the champions crowded four runs over the plate. Stopped by Sakamoto in the next three chapters, the Phantoms drew blood again in the fifth inning with three runs, and added one more for good measure in the sixth frame. Pang toiled on the mound for Phantom A.C. and stopped the Shoten artillery cold. His team-mates were hit-hungry, and gave him superb support afield.

Sin carried the pitching assignment for Phantom A.C. against Royal Malts and turned in a sterling performance. The Phantoms gave Sin an encouraging three-run lead to work on in the first inning and topped them off with one in the second stanza, three in the third, and one in the sixth for their second shutout of the day. Angelise, Phantom short-stop, was in fine hitting mettle against Royal Malts as he connected for two long homers off Eric Pang. Tom Hugo also clouted a round-tripper.

The victory over Royal Malts avenged a previous 3-2 defeat suffered in the regular schedule. Handcuffed by Pang in their first meeting, the Phantoms solved his delivery in the pay-off tilt.

AAU GYMNASTIC MEET SCHEDULED IN PAL GYM

The 1940 A.A.U. Gymnastic Championships will be held Wednesday, May 22, at 7:30 p.m. in the Settlement gym, according to an announcement by Louis Mendonca, chairman of the A.A.U. Gymnastic Committee.

Competition will be held in the horizontal bar, parallel bars, side-horse, flying rings, and tumbling, with all-round champions slated to receive medals. Contestants must compete in all five events to qualify for the all-round awards.

Susumu Kobayashi, deaf-mute ace from Palama Settlement, won the 1939 all-round gymnastic championship by outscoring Deuring of Central YMCA, and Sagawa of Nuuanu YMCA. Kobayashi is slated to defend his title and is reported to be in top form. Stars from Maui County and athletic centers on Oahu are also slated to show in the championships.

SIXTEENTH RAINBOW RELAYS SLATED SATURDAY

Palama Settlement's 1940 senior track team, coached by Charley Ornellas and Reed Maxson, will meet its first test of the season this Saturday, May 11, at the 16th running of the ASUH-sponsored Rainbow Relays at Alexander Field. The Winged "P" cinder stars have been training for two months and are primed to tackle the best that University of Hawaii, Waimanalo A.C., and Citywide A.A. can put on the track.

Charley Ornellas, the peer of all local middle-distance runners, will lead a small but versatile squad into competition. Ornellas is a cinch in his specialty, the half-mile run, and is a match for anyone in the 440-yard dash and the mile race.
